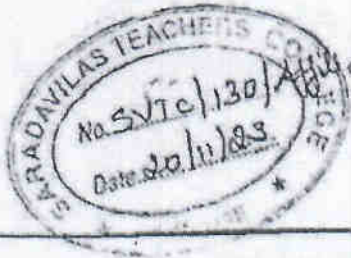



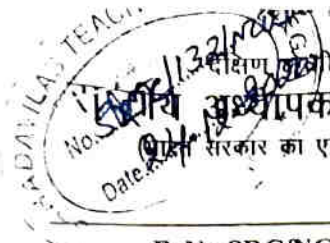

WHEREAS, the institution **Saradavilas Teachers College, Krishnamurthypuram, Mysore- 570004, Karnataka** was granted recognition vide SRC (NCTE) vide order no. F.KAR/B.Ed./61/SRO/NCTE/2000-2001/1576 of dt. 14.08.2000 for conducting B.Ed. course of one year duration with an annual intake of 100 students from the academic session 2000-2001.

AND WHEREAS, after the promulgation of NCTE Regulations, 2014 and as per affidavits submitted by the institution on dt. 12.01.2015, the provisional revised recognition order was issued to the institution on 16.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 from the academic session 2015-16.

AND WHEREAS, the matter was placed before in 314th meeting of SRC held on 27th & 28th May 2016 wherein a general decision was taken to cause inspection of such cases.

AND WHEREAS, as per the decision of SRC, a letter for inspection was sent on 13.06.2016.

AND WHEREAS, the status of issuance of Show Cause Notice/FSCN was considered by the Sub-Committee constituted by the SRC in its meeting held on 22nd October 2019. The Sub-Committee noted that the institutions have not submitted requisite documents or only reply has been submitted. The Sub-Committee decided to issue Show Cause Notice in all such cases. Accordingly, First Show Cause was issued on 24.10.2019.

AND WHEREAS, the compliance submitted by the institution on dt. 13.11.2019 and the matter was considered by the SRC in its 392nd Meeting held on 15th-16th December 2020 as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993. Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The decision of the institution be read as under: -

"On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution Saradavilas Teachers College, Krishnamurthypuram, Mysore-570004, Karnataka for B.Ed programme for 2 basic units of 50 students each unit."

- 9.. The institution shall submit to the Regional Committee a Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter - alia, the details of the institution. its locations. name of the programme(s) with intake; available of physical infrastructure. such as land. building, office. classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. 
