## PROCEEDINGS OF THE GOVERNMENT OF KARNATAKA

**Subject:** Regarding the recommendation to appoint Sri H.M. Manjunath as Assistant Professor of Mathematics in Sarada Vilas Teachers College, Mysore.

**Read:** 1. Letter No. DCI/91-FVP/2012-13/113, dated 23.06.2012 from the Additional Director, Department of Collegiate Education, Bengaluru.  
2. Government Order No. ED 146, U.NE.2011, dated 02.07.2012.

### **Proposal:**

As per the proposal read in (1), the Additional Director, Department of Collegiate Education, Bengaluru, had sent a proposal for inclusion of two teaching staff appointments at the Sarada Vilas Teachers College, Krishnamurthipuram, Mysore for salary grants.

In the said proposal, the Additional Director, Department of Collegiate Education, Bengaluru, states that the Sarada Vilas Teachers College, Krishnamurthipuram, Mysore - 570004, has been receiving grants since 1977 and there are no cases filed against the institution in any of the courts anywhere in the state. Also, the said institution possesses all the requisite basic infrastructure and facilities as prescribed by the N.C.T.E. Also, the teaching staff who are serving in the institute have submitted details regarding their educational qualifications as required under the rules and regulations for appointment of teaching staff prescribed by the UGC - N.C.T.E. State Government, in the report submitted with reference to the educational institute. It has been stated that the admissions' institute has submitted all the relevant documents with regard to the educational qualifications of its teaching staff and the same has been scrutinized. Also, that the teaching and non-teaching staff patterns have been determined by the College.

As per the Government Order, read as in (2), the Finance department, in its note no. FD/291 Expenditure - 8/20/2012 dated 19/06/2012 had given its approval for the appointment of 2 teaching staff vacancies in the Sarada Vilas Teachers College, Mysore, that had fallen vacant due to retirement, resignation or death. The appointments to the 2 posts should be made as follows: Appointment to 1 post from the General Category and appointment to the other post should be made from the Scheduled Tribe (ST) category. Sarada Vilas Teachers College is one among the several government aided colleges in the state.

In the light of the above facts, the Additional Director, Department of Collegiate Education had sent his proposal recommending the inclusion of Sri H.M. Manjunath, Assistant Professor of Mathematics, Sarada Vilas Teachers College, Krishnamurthipuram, Mysore-570004 for salary grants, as he is eligible. The proposal was closely scrutinized and accepted. Accordingly, the following Order is being passed.

In the light of the facts stated in the proposal, Sri H.M. Manjunath, Assistant Professor of Mathematics, Sarada Vilas Teachers College, Krishnamurthipuram, Mysore has been approved for inclusion under the ST category, subject to the following conditions:

1. Before including the teaching staff appointments under salary grants, it has to be ascertained that all the eligibility conditions as per the rules and regulations stipulated by the UGC are strictly adhered to.

2. It has to be ascertained that the proposed staff appointments, which are to be included under the salary grant have been made due to the vacancies created due to retirement, death, or resignation, as per the Government Order mentioned previously.
3. Salaries to the appointed staff can be released only after obtaining all the relevant documents required under the Government Order no. ED-46/SEP/2006 and the same has been scrutinized and ascertained.
4. Before releasing any salary payment to the appointed staff, it has to be ascertained that the documents submitted by the concerned persons with regard to their educational eligibility, age and reservation criteria are being met as per the laws, rules and regulations and the appointments are made in a transparent manner.
5. It is to be ascertained that, in order to provide service security to the appointed staff, he/she is included in the HRMS.
6. As per the Karnataka aided private institutions Staff (Salary, Retirement and other Benefits Regulations) Act 2014, the staff of these institutions will not be eligible to avail any of these benefits mentioned in the act, for the services rendered during the period in which the institution was aided.
7. For interim salary grants, i.e. from the date of the issue of this order, the salary should be fixed at the lowest salary grade of the concerned staff position as per the stipulated rules and regulations.
8. It is to be ascertained that the approved staff positions are as per the staff positions approved by the government.
9. The Governing Board should provide a contract letter stipulating the conditions laid out above, as per the rules and regulations, on a Rs. 50 Document Sheet duly verified by a notary.
10. In case of any violations with regard to all or any one of the stipulated terms and conditions in the agreement, by the Governing Board or if the Board presents false accounts or commits frauds, the Government will have the authority to discontinue or hold back in full or in part, the salary given to the Governing Board or the staff member. Also, the government has the authority to collect amount due to it from the administrative board.
11. In case of any false statements or information provided by the approved staff, the government will have the authority to cancel such appointments.
12. The said salary grant will come into effect from the date of issue of this order. Under no circumstances the service-related period prior to this order should be considered for the grant.
13. The salary should be released only after ascertaining that the documents related to the educational qualifications, Marks Statements and Certificates submitted by the teaching/non-teaching staff of this college are duly scrutinized and verified by the relevant authorities.
14. While releasing the salary grant to the teaching staff, it has to be ascertained that the documents submitted by them with regard to their educational qualifications, age limit and caste certificates are in order by the relevant authorities. Only after personally ascertaining their veracity should the salary grant amount should be released. Further, the originals of the caste certificates submitted by the staff belonging to the Scheduled castes and Scheduled Tribes should be verified and ascertained.
15. With the exception of the Universities in Karnataka, Marks Statements and Certificates issued by Universities from states should be verified and ascertained.
16. The salary grant should be released only after scrutinizing and ascertaining that the teaching staff has a specific workload during every year and the same is verified and ascertained by the Commissioner - Joint Director of the Department of Collegiate Education.

17. In case, the information or the documents provided in the proposal are found to be false at a later date, suitable action will be taken against the concerned persons.
18. There should be no disputes within the Governing Board. In case of disputes, such institutions will not be eligible for the grant.
19. The expenses incurred for appointing an Assistant Professor should be reimbursed from the budgetary allocations made by the Education Department subject to the specified limits mentioned in this Order. Under no circumstances, additional budgetary allocations should be sought. The expenses should be recorded under the account heading "2202-03-104-2-01-101 (unplanned)" and complete details I.V related to this account head should be recorded in the specified checklist for the year 2015-16 and the same should be availed.

## PROCEEDINGS OF THE GOVERNMENT OF KARNATAKA

**Subject:** Regarding granting approval for the appointment of Smt Zaira Abraham for the vacant post of Assistant Professor in Sarada Vilas Teachers College, Mysore.

**Read:** 1. Government order no. ED 145, (WE) 2011 dated 02/07/2012.  
2. Letter no. DCI-51/ADU/12-130/ED dated 26/10/2015 and 30/12/2015 from the Director, Department of Collegiate Education, Bengaluru.

### Proposal:

The finance department, in its order no. FIC-291, Expenditure-62012 dated 14/06/2012 has granted approval and consent for the appointment for 2 staff posts: one candidate from the General Category and one from the Scheduled Tribe category to fill the vacancies that had arisen due to retirement, resignation or death in Sarada Vilas Teachers College, Mysore. (No. 17) a government aided institution listed as per the Government Order no. ED 145 (1) and issued as order in this regard.

The Additional Director, in his letter, as read in (2), had scrutinized proposal of seeking approval for the selection of Smt. Zaira Abraham by the Selection Committee, for the post of Assistant Professor of Physics which had fallen vacant in Sarada Vilas Teachers College. After ascertaining that the College has been receiving grants since 1964 and the existing workload due to vacant posts in the said college, and after ascertaining that the selected candidate possesses the required educational qualifications for the post of Assistant Professor of Physics and is eligible for reservation. That there are no criminal cases filed against the candidate. After ascertaining the staffing pattern that is necessary for the college, the Additional Director had recommended to the government that Smt. Zaira Abraham be appointed as Assistant Professor of Physics in the college. After examining the recommendation, the following Order is being issued.

### GOVERNMENT ORDER no. ED 581/RC2015, BENGALURU Dated 15/04/2016.

In the light of the points mentioned in the proposal, the selection and appointment of Smt. Zaira Abraham, by the Selection Committee for the post of Assistant Professor of Physics in Sarada Vilas Teachers College has been approved subject to the following conditions:

#### Conditions:

1. It has to be ascertained that the workload for the teaching posts are as per UGC norms before including the staff norms for the salary grant.
2. It has to be ascertained that the proposed posts were already included for the salary grant and the posts fell vacant due to retirement, resignation, death.
3. To fill the posts, disbursement as mentioned in the Government Order no. ED 145, WE, 2011, dated 12/04/2011 were closely scrutinized and the facts are ascertained. Only after ascertaining the facts, the salary grant amount should be released.
4. While making appointments in the posts, it has to be ascertained that the selected candidate's educational qualifications, age and eligibility for reservation and other rules and regulations that are in force are being followed and the appointment is made in a

transparent manner. Salary should be released only after scrutinizing all the relevant documents.

7. It is to be ascertained that, in order to provide service security to the appointed staff, he/she is included in the H.R.M.S.
8. As per the Karnataka aided private institutions Staff Salary, Pension and other Benefits Regulations Act 2014, the staff of these institutions will not be eligible to avail any of these benefits mentioned in the act, for the services rendered during the period in which the institution was founded.
9. For future salary grants, i.e. from the date of the issue of this order, the salary should be fixed at the lowest salary grade of the concerned staff position as per the stipulated rules and regulations.
10. It is to be ascertained that the approved staff positions are as per the staff positions approved by the government.
11. The Governing Board should provide a contract letter stipulating the conditions laid out above, as per the rules and regulations, on a Rs. 50 Document Sheet duly certified by a notary. It should release the aid only after receiving the contract agreement.
12. In case of any violation with regard to all or any one of the stipulated terms and conditions in the agreement, by the Governing Board or if the Board presents false accounts or commits frauds, the Government will have the authority to discontinue or hold back in full or in part, the salary given to the Governing Board or the staff member. Also, the government has the authority to collect amount due to it from the governing board.
13. In case of any false statement or information provided by the approved staff, the government will have the authority to cancel such appointments.
14. The said salary grant will come into effect from the date of issue of this order. Under no circumstances the service related to period prior to this order should be considered for the grant.
15. The salary should be released only after ascertaining that the documents related to the educational qualifications, Marks Statements and Certificates submitted by the teaching non-teaching staff of this college are duly scrutinized and verified by the relevant authorities.
16. While releasing the salary grant to the teaching staff, it has to be ascertained that the documents submitted by them with regard to their educational qualifications, age limit and caste certificates are in order by the relevant authorities. Only after personally ascertaining their veracity should the salary grant amount should be released. Further, the originals of the caste certificates submitted by the staff belonging to the Scheduled castes and Scheduled Tribes should be verified and ascertained.
17. With the exception of the Universities of Karnataka, Marks Statements and Certificates issued by Universities from states should be verified and ascertained.
18. The salary grants should be released only after scrutinizing and ascertaining that the teaching staff has a specific workload during every academic year and the same is verified and ascertained by the Commissioner/Joint Director of the Department of Collegiate Education.
19. In case, the information or the documents provided in the proposal are found to be false in a later date, suitable action will be taken against the concerned persons.
20. In case, the information or the documents provided in the proposal are found to be false in a later date, suitable action will be taken against the concerned persons.
